After inhalation

Provide fresh air. Medical treatment necessary. In case of accident by inhalation: remove casualty to fresh air and keep at rest. If unconscious but breathing normally, place in recovery position and seek medical advice. In case of respiratory tract irritation, consult a physician.

After contact with skin

After contact with skin, wash immediately with plenty of water and soap. Take off immediately all contaminated clothing and wash it before reuse. If skin irritation occurs: Get medical advice/attention.

After contact with eyes

In case of contact with eyes flush immediately with plenty of flowing water for 10 to 15 minutes holding eyelids apart and consult an ophthalmologist. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

After ingestion

Observe risk of aspiration if vomiting occurs. Do NOT induce vomiting. Adverse human health effects and symptoms: Gastric perforation. Call a physician immediately. Do not allow a neutralisation agent to be drunk. Rinse mouth thoroughly with water. Let water be drunken in little sips (dilution effect). Seek medical advice.

4.2. Most important symptoms and effects, both acute and delayed

Acute effects: Mucous membrane irritation after eye contact or inhalation.

Delayed effects: Impairment of inhibitory functions of the central nervous system, skin redness, nausea after ingestion of large amounts.

4.3. Indication of any immediate medical attention and special treatment needed

Treat symptomatically.

Percutaneously absorbed and inhaled substance causes next to irritation of affected mucous membranes only an indicated impairment of the inhibitory functions of the central nervous system, clinically recognizable as the beginning of a euphoric stage. At the same time face and skin redness is caused by dilation of peripheral blood vessels in the body.
