SECTION 4: First aid measures

4.1. Description of first aid measures

General information

Remove affected person from the danger area and lay down. In case of accident or unwellness, seek medical advice immediately (show directions for use or safety data sheet if possible).

After inhalation

Provide fresh air. If unconscious but breathing normally, place in recovery position and seek medical advice. In case of respiratory tract irritation, consult a physician.

After contact with skin

Wash with plenty of water. Take off contaminated clothing and wash it before reuse. In case of skin irritation, seek medical treatment.

After contact with eyes

After contact with the eyes, rinse with water with the eyelids open for a sufficient length of time, then consult an ophthalmologist immediately. Remove contact lenses, if present and easy to do. Continue rinsing.Medical treatment necessary.

After ingestion

Observe risk of aspiration if vomiting occurs. Rinse mouth thoroughly with water.Let water be drunken in little sips (dilution effect).Do not allow a neutralisation agent to be drunk.Medical treatment necessary.

4.2. Most important symptoms and effects, both acute and delayed

Acute effects: Mucous membrane irritation after eve contact or inhalation.

Delayed effects: Impairment of inhibitory functions of the central nervous system, skin redness, nausea after ingestion of large amounts. By swallowing danger of perforation of the esophagus and the stomach exists (strong corrosive effects).

4.3. Indication of any immediate medical attention and special treatment needed

Treat symptomatically.

Percutaneously absorbed and inhaled substance causes next to irritation of affected mucous membranes only an indicated impairment of the inhibitory functions of the central nervous system, clinically recognizable as the beginning of a euphoric stage. At the same time face and skin redness is caused by dilation of peripheral blood vessels in the body.
