SECTION 4: First aid measures

4.1. Description of first aid measures

General information

First aider: Pay attention to self-protection! Remove affected person from the danger area and lay down. In case of accident or unwellness, seek medical advice immediately (show directions for use or safety data sheet if possible).

After inhalation

4.2. Most important symptoms and effects, both acute and delayed

No information available.

4.3. Indication of any immediate medical attention and special treatment needed

Treat symptomatically. Percutaneously absorbed and inhaled substance causes next to irritation of affected mucous membranes only an indicated impairment of the inhibitory functions of the central nervous system, clinically recognizable as the beginning of a euphoric stage. At the same time face and skin redness is caused by dilation of peripheral blood vessels in the body.

SECTION 5: Firefighting measures

6.1. Personal precautions, protective equipment and emergency procedures

General advice

Remove all sources of ignition. Provide adequate ventilation. Do not breathe gas/fumes/vapour/spray. Avoid contact with skin, eyes and clothes. Use personal protection equipment. Ventilate affected area. Special danger of slipping by leaking/spilling product.

For non-emergency personnel

SECTION 7: Handling and storage

7.1. Precautions for safe handling
