General information

Remove affected person from the danger area and lay down. In case of accident or unwellness, seek medical advice immediately (show directions for use or safety data sheet if possible).

First aider: Pay attention to self-protection!

Remove contaminated, saturated clothing immediately.

After inhalation

Provide fresh air. Medical treatment necessary. If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. If breathing is irregular or stopped, administer artificial respiration. Where appropriate artificial ventilation. In case of respiratory tract irritation, consult a physician.
